Application for a License to Purchase a Firearm

A license to purchase a pistol expires **30 calendar days** after the date of issue. If this license is used to purchase a pistol, the "LICENSING AUTHORITY" copy must be brought back to CHPD records within 10 calendar days of purchase. Failure to follow state and federal regulations may result in pistol confiscation and you being in violation of the law. If you have any questions, please ask the assisting official.
